As a thank you for your support the LCHA will hold a draw twice a year (at the AGM and the Harvest Supper). All 100 club members will be eligible for the draw and providing there are at least 100 members there will be a price of £100 plus 2 runners up prices of £25 at each draw.

## **HER MAJESTIES CUSTOMS AND EXCISE GIFT AID SCHEME**
